### New Propane System at WFF

September 17, 2010

Some of the new construction at WFF over the summer is related to a new underground propane distribution system. This system will be used to heat individual buildings and eventually remove the steam heat system that has exceeded its useful life. This system is very safe and will provide WFF with a more efficient energy source for our future. With any new system comes a new set of benefits and risks. This will now also require new boiler systems to be installed in some building mechanical rooms. We will also have training in place for maintenance, response personnel, and FOMs for these new systems. We will begin activating these systems soon. For most employees this will not result in any changes to the work environment, however, if you hear, see or smell something that may be related to a gas leak or you have any concerns related to these systems, please call the Facilities Help Desk at X-4357 (HELP).

#### Hurricane Awareness Update

Hurricane Earl graced us with his passing on Friday the 10<sup>th</sup>. While we saw minimal impacts from this system, it was a reminder of just how much difference a few miles can make. The photo below was taken on Wallops Island about 2:00 PM as the system made its closest pass. At this time the system was a degrading Category 2 storm nearly 200 miles away. While we were outside the wind field for even the Tropical Storm winds, as you can see the wave action was impressive and minor beach erosion was detected. We still have a month of the active hurricane season ahead of us and with two storms currently in the Atlantic basin we need to be aware.

## Energy Conservation



October is Energy Awareness Month. By developing renewable resources and using efficient technologies, we can protect the environment, stimulate the economy, and increase energy security. To reach the federal goal requiring 3% energy reduction per year by 2011 (compared to 2003), we all must do our part.

**Make a habit of using these simple tips to save energy around your office:**

- leaf Combine trips, share rides, or walk to meetings and the cafeteria.
- leaf Use natural lighting and task lighting when possible.
- leaf Wear a sweater instead of turning on personal heaters to warm-up in the mornings.
- leaf In summer, reduce cooling needs by closing window blinds to block direct sunlight.
- leaf In winter, reduce heating needs by opening blinds on south facing windows during the day.
- leaf Turn off computers and monitors at the end of the day.
- leaf Turn off office, kitchen, bathroom, and hall lights when not in use.
- leaf Unplug energy draining equipment when not in use (i.e. cell phone chargers and coffee makers).
- leaf Select duplex printing.
